### How we use your data

### Automated decisions

PosadMaxwan will not sell your data to third parties and will provide them only where necessary for the execution of our agreement with you or the fulfilment of a legal obligation. With other companies that process your data on our behalf, we conclude data processing agreements to ensure a consistent level of data security and confidentiality. PosadMaxwan remains responsible for data processing.

PosadMaxwan uses functional cookies on its site to optimise user-friendliness. We also use anonymised analytical cookies. We ask your permission to place Google tracking cookies, so we can offer relevant content on our website. PosadMaxwan has no influence on the way Google places cookies on our website and has no access to the data collected.
